Part B. CV SUMMARY.

Researcher in Philosophy of Law and "Theory of Justice and Human Rights" with two six-year research periods. My research lines in relation to the R&D project applied for are ecological justice and the rights of nature; legal feminism; justice and social rights and the new paradigms of international criminal justice. My involvement in research applied to tourism and tourist areas arose from the study of legislation on important tourist resources such as the Atrato River in Colombia, the Mar Menor, and Doñana.

Promoter of the Mar Menor Popular Legislation Initiative (ILP) aimed at recognizing the legal personality of the Mar Menor, for which I have won several awards. Promoter of the Legal Clinics of the Faculty of Law at the University of Murcia.

Director of the Chair in Human Rights and Nature, for which I have been invited to several editions of the United Nations Conference on Biodiversity (COP), the last one held in Egypt in 2022. The Chair highlights the interdisciplinary work of disciplines from the Humanities, Social Sciences and Law, and Natural Sciences: Law, Social Work, Geography, Philosophy, Education, Psychology, Sociology, Economics, Biology, Ecology, etc. The Chair also integrates non-governmental organizations such as Amnistía Internacional España and Ecologistas en Acción de la Región Murciana.
