Major Research Interests

Since 1981 my primary research site has been Sri Lanka. My original work there focused on rural change, politics and nationalism. I have since published on the causes and consequences of ethnic violence. Since 2004 I have been involved in a string of collaborative projects with Sri Lankan colleagues, on politics and religion, and most recently on urban housing, and the history of political dissent. I have also published occasional articles on Buddhism, and on the institutional history of British anthropology.
