Summary:	The topic of the PhD thesis is the voting behaviour of young people in six European countries between 1981 and 2000. The core question of the thesis concerns the determinants of voting behaviour among the young, and the extent to which these determinants are different from those of older generations of voters. Another research goal is to disentangle "cohort effects", from "age effects" and "period effects" according to the definitions given by the literature when analysing the vote. In general, the strategy of analysis is based on a novel application to vote choice variables of the stacked-dataset, i.e. a multilevel analysis design. Overall results show that when we consider the relationship between age and vote what prevails is not the "age effect", but the "generation effect". In other words, to understand voting choices is not important the fact of being young, but to have been young and therefore have been socialized to politics in a given historical period. Furthermore, young European voters in the Eighties, Nineties and early years of the new millennium are not so different from their parents for what concerns the reasons underlying their voting behaviour. There is not a generation divide in this regard. That said, the analysis shows that values and political factors are more useful for understanding the voting choices of young people than social identities. This was not the case for the previous generations in the past.

DESCRIPTION OF THE RESEARCH:

My main research interests are socio-political attitudes, electoral systems, voting behaviour and party competition in a comparative perspective. My academic work deals primarily with quantitative research and statistical analysis of cross-national surveys, linking micro, meso and macro data through multilevel research designs. Throughout my research I have dedicated a special attention to the study of youth political attitudes and behaviours. This interest dates back to my PhD thesis, which was about the voting behaviour of young people in six European countries between 1981 and 2000, trying to detect those that in the literature are defined as ‘age’, ‘generation’ and ‘period’ effects. On the same topic, I published a book for Palgrave Macmillan on young people’s voting behaviour in Europe (*Young People’s Voting Behaviour in Europe. A Comparative Perspective*). This book investigates youth voting behaviour in six European countries (1981-2000) and explores the role of age, generation, and period effects in shaping party choice. Empirical findings show that values and political factors influence youth voting more than social identities, and socialization in a particular historical period has a stronger effect than age alone. It appeals to scholars of comparative politics, electoral behaviour, and political sociology.

- Employs a mixed-method, multi-method, longitudinal strategy that features multiple components: from mass surveys, to social media content (also analysed through automated methods and AI coding), to dedicated surveys aimed at secondary-school students, to qualitative in-depth interviews with young people.
- In particular, I have coordinated the Work Package on secondary school students, supervising and conducting surveys in 20 public secondary schools (comprising lyceums, technical institutes, and vocational schools) with about three classes per school (either fourth or fifth year) for a total of around 60 classes and 834 students

6. Jean Monnet Fellowship (European University Institute) – Individual project “New challenges for representative democracy: the changing political space in Western Europe”.

- I investigated whether traditional one- or two-dimensional models of political competition still apply I examined the fragmentation of issue preferences among European voters, using original survey data from the Issue Competition Comparative Project (ICCP).

- I focused on the growing ideological inconsistency in voter attitudes, especially among young voters and right-wing voters. Findings published in the *Italian Journal of Electoral Studies*, showed that most voters are ideologically inconsistent on cultural (GAL-TAN) and economic (left-right) issues, whereas they remain consistent on immigration and EU-related issues.

7. Issue Competition Comparative Project (ICCP)

- A comparative study (directed by Prof. Lorenzo De Sio) of party competition on campaign issues in nine Western countries: Austria, France, Germany, Italy, Netherlands, Poland, Spain, UK, and USA
- Uses an innovative research design combining:

 - Manual coding of party Twitter communication (analysing campaign strategies).
- Identifies key electoral issues for each party, assessing which issues parties emphasized and whether parties exploited their competitive advantages.
- First round (2017-2018) covered six Western European elections, results published in *West European Politics*.
