## CURRENT PROJECTS AND FUTURE RESEARCH

(1) Translation and comment of V. Putin's discourses linked to historical events or references. For Viella (Roma), series "Memorial Italia". [in Italian]

(2) "Fedor Fedorenko: Crimes and Judgment Between West and East in Hot and Cold War." Examines inter-bloc competition and cooperation on criminal investigations of the most seriously implicated (but unindicted) perpetrators of crimes from World War II. It looks into the weaving together of justice, history and memory, focusing not only on the state and other institutional actors, but also on various civil actors, from individuals to sophisticated international organizations like the World Jewish Committee. Fedorenko, a former Red Army soldier who served the SS as a guard at Treblinka extermination camp, emigrated to the United States after the war as a displaced person, and ultimately was removed in December 1984 after a ten-year procedure to Soviet Ukraine where he faced criminal charges for capital crimes in 1986 and was executed. My project puts at its core an examination of the roles of government actors, Jewish organizations, and diaspora elements that operated in the public and private sectors to shape U.S. policy on 'Nazis in America'; its sources include research in NARA in the U.S. and various NGO records in New York City and Cincinnati, as well as interviews with those involved in the U.S. case: activists, prosecutors, journalists, and historians. The Soviet side of the story is based on my copy of documentation file from Ukrainian state archives and from the Ukrainian Security Service archives (most importantly the complete Soviet case in 23 volumes, a transnational and diachronic body of source materials in itself). The Fedorenko case offers a window onto the end of the Cold War, the unexpected cooperation between the U.S., the U.S.S.R., Poland, and Israel, and the specifically Gorbachevian treatment of World War Two and Holocaust memory. (3) "The True War? Soviet operators and directors of documentary films in the Second World War." Aims to fill a gap in non-Russian-speaking studies of Soviet cinema. The latter is most often studied for its contribution to the avant-garde (in fiction or documentary) or, on the contrary, for the political and ideological function that was increasingly narrowly assigned to it from the Stalinist period onward. Focusing on how the film industry in the USSR mobilized to film an unprecedented conflict, the World War II the book shifts the focus from the political authorities to the production structures: from the ministerial directorate in charge of documentary films to the studio and director at the front. This shift allows us to interrogate in a new way the unpublished images captured by Soviet cameras in 1939–1945. The goal is to understand what meaning(s) the various actors—minister, section chief, studio director and censor, editor and finally frontline cameraman—may have given to their work and work. The book is the result of several years of research, carried out in part as part of a collective project in Moscow, Minsk and Kiev. The analyses are based on documents consulted at GARF (State Archives of the Russian Federation), RGALI (Russian State Archives of Literature and Art), RGASPI (Russian State Archives of Social and Political History), CDMLM (Ukrainian State Archives-Museum of Literature and Art). It consists of five analytical chapters and two documentary sections (in close connection with the corresponding chapters), i.e., archival documents translated from Russian and annotated.
